A case may have more than one final order determining the value of property securing a claim. A case is counted in a category if it has one or more final orders determining the value of property securing a claim that meet the criteria for the category. Not all final orders determining the value of property securing a claim that were reported included a determination as to the relationship of the value to the amount of the claim. The United States territorial courts assume the jurisdiction of United States bankruptcy courts within their respective territories, which do not have separate bankruptcy courts.
